1. Welcome, introductions – Sandra Robertson

- Sandra welcomed everyone and thanked them for their attendance
- Sandra invited Anna-Lyn to introduce themselves as the new Community Entity Coordinator
- Anna-Lyn invited Karen D'Souza, Service Canada to introduce herself as the new liaise for Reaching Home Program
- Sandra invited the CABH members to introduce themselves
- Anna-Lyn gave a land acknowledgment that we are on the unceded territory of the Syilx Nation
- Sandra called the meeting to order

2. Approval of September 29<sup>th</sup>, 2022, Agenda and July 28<sup>th</sup>, 2022 minutes

- Sandra presented September 29<sup>th</sup>, 2022, agenda, no new items were raised.
- Motion to approve July 28<sup>th</sup>, 2022, minutes: Elaine, Seconded: Naomi
- Motion to approve, September 29<sup>th</sup>, 2022, agenda: Liz Seconded: Jared

# 3. CAB-H Chair update

Sandra addressed the membership vacancies and inquired with Cheryl what the ongoing recruitment strategy will be, while emphasizing the need for the Co-Chair and Chair positions to be priority due to them being occupied by interim members.

- Cheryl explained the process of recruitment will involve an application that will be submitted through the Central Okanagan Foundation website and that it would be appreciated if the CAB-H put some thought into individuals who are of viable interest. The application will be going onto the website near the end of November
- Naomi expressed that someone has approached them regarding the Seniors seat

Sandra also addressed that Anna-Lyn proposed an LGBTQIA2S+ seat be added to the CAB-H positions. Sandra addressed that a Diversity and Inclusion position already exists and asked for discussion. Elaine expressed that she believes the LGBTQIA2S+ seat would be distinct and would represent an ever-growing/ever-existing community in the sector.

# 4. Community Entity Update

Anna-Lyn expressed that the CE received an extension for their submission of the Community Homelessness Report (CHR), making the new submission date November 7<sup>th</sup>. Anna-Lyn explained that it requires CAB-H approval three weeks prior to its submission. As such, they will be sending out the document on October 12<sup>th</sup> to receive CABH approval via email by October 17<sup>th</sup>.

5. Approval of Additional Funding - Project Review Committee Recommendations 2022-2024

Members excused due to conflict: Liz, Jared, Mike, Elaine Liz, Jared, and Mike are employed by organizations that applied for funding. Elaine was a member of the Project Review Committee (PRC).

Decision made to go through each proposal alphabetically as in the format of the Grant Summary document which was distributed in the CAB-H package. Sandra will distinguish each proposal from each organization, what fiscal year/s they applied for, how much was requested and how much was recommended by the PRC. Discussion will be open for each proposal.

Cheryl explained that the PRC used an assessment tool for each project, and each organization was given the assessment tool to see how they would be scored in advance.</li> <li>Janet asked how the financial amounts were adjusted and Cheryl explained that the meeting was 5 hours due to this part of the process. She explained that the breakdown of the budget was investigated, and discussion ensued about appropriate reductions that could be done while still maintaining the viability of the projects. Chery also explained that when the agreements occur, the budget can/will be renegotiated, and that it is a working budget.</li> </ul>

- Naomi raises a question about the Project Review Committee notes for this application. Found the comment vague in second fiscal year
- Anna-Lyn explains that the Food Bank was lower-scored in the first fiscal year and only two individuals were able to participate in deliberation, the rest were in conflict. The two individuals who could vote had opposite recommendations; one was to fund the other to not. They did not want to go back on their "no's", as this was the last remaining decision for the first fiscal year, and the individual who was not initially for funding, was compelled to fund this round with the remaining amounts due to better understanding the need and amount of people benefiting from the program; as well as to not revert on already made decisions (ex. Changing a previous no to a yes, changing an amount already allocated to a recommended proposal).
- Naomi expresses that it may be problematic if its because there was no money left, Cheryl expressed it's not because there wasn't enough money, its that both decided not to fund the second year and it was one of the lowest scored; both individuals were compelled to not fund for the second fiscal year.

- Naomi expressed that they aren't aware of other hygiene programs that the community can access, and is worried about a large gap in the community for accessing this kind of support
- Cheryl explains that it isn't for the hygiene program, as its title is misleading, its for casework and *expanding* their hygiene program. Cheryl identifies that the proposal included a community meal program, social and practical supports to those who are already accessing the program, the successful transition of clients into employees, and the proposal for developing a caseworker role
- Anna-Lyn explains the grant summary document contains their exact words for objective and activities if there is any confusion
- Sandra summarizes that its expanding services for people already accessing the hygiene program
- Don reiterates that it seems about hiring a new position than hygiene per se
- Cheryl confirmed; that is correct

- Janet asks if this proposal is about people with lived experience doing work within the community, and is curious about the Data Collection, Analysis, and Use being done by this organization
- Anna-Lyn explains that, the Data Collection, Analysis, and Use is a broad Reaching Home Directive that proposals can indicate as part of their proposed funding. PEOPLE specified that they would fulfill that activity through utilizing the funds to support their Weekly Rental Vacancy listing which the PRC understood as a very helpful tool in the community as far as helping people find housing (particularly those who may not have a caseworker, be on a waitlist, or who do not have access to the internet regularly). Anna-Lyn explains that it is, in fact, funding people with lived experience having employment in the community as the application outlines the delivery of a 2-peer cohort training for up to 30 People with Lived Experience to help them improve baseline communication and 'job readiness'. As well, the proposal

involves, "In Work Peer Support" which includes a social work mentor who provides a 1 hour bi-weekly of continual training and mentoring support for up to 30 employees for a period of 6 months per employee

# Additional Commentary:

- Naomi expressed that she noticed a trend in the PRC minutes where when the organization's found it difficult to put their point across in writing, it was difficult for the PRC to score them and decide on funding, she expressed curiosity in potential shifts in the application process for those who struggle with writing applications or do not have adequate resources
- Sandra agrees that to penalize organizations who don't have grant writers in their membership, and therefore may struggle to get their points across in writing
- Cheryl responded with an example of the Bridge, who has a qualified grant writer and yet both their applications were denied and reiterates that all applicants were given the assessment tool to guide their writing/formatting.
- Janet asks if feedback is given to the proposals that are denied. Cheryl explains that they do.

Motion to award the 2022-2023 fiscal year funds per the recommended amounts from the Project Review Committee's adjudication as indicated in the Grant Summary document: Sandra, Seconded: Don.
